ORDINANCE NO. 2025 - 24

AN ORDINANCE SETTING CERTAIN FEES AND RATES FOR 2026 FOR FACILITIES AT THE NEW LONDON RESERVOIR AND RECREATION PARKS

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW LONDON, HURON COUNTY, OHIO, AS FOLLOWS:

Section 1. That, *effective for the 2026 season*, and notwithstanding any prior Ordinance, certain facilities/activities at the New London Reservoir or the New London Recreation Park shall be assessed with the following new rental fees and terms:

Reservoir Park & Campground

Rates

Admission: (under 3 is free) \$3
Overnight Guest in Dwelling \$5

Primitive Rates

\$30/night \$180/week \$540/month *Special Events Add ~~\$2010~~ a Night
\$1,800/season

Water & Electric Rates

\$40/night \$240/week \$720/month *Special Events Add ~~\$2010~~ a Night
\$2,200/season

Full Hook-Up Rates

\$50/night \$300/week \$900/month
*Special Events Add \$10 a Night
~~\$2,700~~ ~~2,300~~/season

(Rates are based on 2 adults and 2 children per night. Additional people \$5 each. Children under 3 are free. Must be 18 with a valid state ID to camp)

Cabin Rental: \$80 Sun-Thurs

\$125 Fri-Sat /night rated for 6 people
*Special Events Add \$10 a Night

Shelter Rates

Shelter #1: \$20 plus admission or \$150 includes all guests
Shelter #2: \$40 plus admission or \$200 includes all guests
Stage: \$50 plus admission or
\$200 includes all guests

Chapel: \$150; includes all guests

No refunds for any reservations only rain checks

Inside Village Residents or Organizations/Clubs

Rental = \$500.00 day of event

\$100.00 additional per day for the night before and/or day after.

Non-Profit (501C3) - Rental waived 1 time per calendar year. Any additional rentals are at full price.

- Donations to cover the cost of utilities is appreciated.

Funerals - \$200.00

Funeral Dinners - \$150.00

Benefits (Terminal Illness or Accident) - \$100.00

New London Schools Graduation Parties - \$300.00

New London Local Schools – Rental waived for school functions.

Outside Village Residents or Organizations/Clubs

Rental = \$500.00 day of event

\$100.00 additional per day for the night before and/or day after.

Non-Profit (501C3) - Full price of building rental.

Funerals - \$250.00

Funeral Dinners - \$200.00

Benefits (Terminal Illness or Accident) - \$150.00

****Organizations/Clubs that camp or utilize park grounds = Building Rentals + \$30 per campsite. (Any damage done to park by vehicles/equipment will be charged \$30 per hour + material for repairs.)**

****Auctions that utilize park grounds = Building Rentals + \$250.00 (Auctions are liable for any damage done to park by vehicles/equipment and will be charged \$30 per hour + material for repairs.)**

****Special Events****

Rec Park & Reservoir

- \$250/day for park rental on top of Hileman Building rental. Camping is not included. The event holder must still let the public into the park free of charge to use park facilities.
- Setup Fees - \$20 per hour per employee and \$25 per hour for equipment will be charged. (For setting up tents, fences, etc.)
- Amphitheater Rental - \$200 per day.

If the reservoir must be closed down for an event, there will be a \$150 per day fee.

Pavilions

\$30

Primitive Camping

\$30/night, \$180/week \$540/month

Water & Electric Hookup

\$40/night, \$240/week, \$720/month, \$2,200/season

Dump Station

Free for campers

\$10 for non-campers

Must be 18 with a valid state ID to camp.

50% deposit due at time of reservation.

Rates based on 2 adults & 2 children per night.

\$5 additional for each person.

3 and under are FREE.

No refunds for any reservations only rain checks

Any fees or rates previously set by the Village for items or services not listed above shall continue in effect, subject to future revision by Council.

Section 2. That this Ordinance shall take effect at the earliest period allowed by law.
