

## **NEW LONDON RESERVOIR PARK AND RULES UPDATED NOVEMBER 2022**

1. SPEED LIMIT THROUGHOUT THE PARK AND CAMPGROUND IS **5 MPH**.
2. A CAMPSITE INCLUDES A PAD FOR THE CAMPER, FIRE RING, AND PICNIC TABLE. ONE CAMPER PER SITE!
3. ONE VEHICLE IS TO BE PARKED PER SITE UNLESS THERE IS ENOUGH ROOM FOR TWO VEHICLES. ALL OTHER VEHICLES MUST BE PARKED IN THE VISITORS PARKING LOT.
4. DECKS ARE PERMITTED, BUT MAY NOT BE PERMANENTLY INSTALLED, MUST BE OFF GROUND, AND APPROVED BY VILLAGE ADMINISTRATOR OR PARK DIRECTOR.
5. **OUTSIDE REFRIGERATORS 4.5 CU FT /PORTABLE (window)AIR CONDITIONER are permitted with a \$50.00 fee.**
6. ONLY ONE OUTSIDE SHED IS PERMITTED PER SITE. IT IS TO BE PLACED AT THE BACK OF THE CAMPER OR UP ON THE DECK. MEASUREMENTS ARE NOT TO EXCEED **49 sq ft**. RUBBERMAID, WOOD, OR METAL CONSTRUCTION IS ACCEPTABLE. **NEEDS APPROVAL FROM PARK SUPERVISOR AND VILLAGE ADMINISTRATOR BEFORE CONSTRUCTION CAN START.** (HAND IN BLUEPRINTS TO OFFICE)
7. ELECTRIC CORD AND WATER HOSE MAY BE PLACED UNDERGROUND IN **CONDUIT PIPING** ONLY.
8. CAMPERS ARE REQUIRED TO **MOW AND MAINTAIN THEIR CAMPSITE**. IF NOT, THE VILLAGE WILL DO THE NECESSARY MAINTENANCE AND WILL ASSESS THE LOT HOLDER FOR THE COST **STARTING AT \$25.00.**
9. GOLF CARTS ARE PERMITTED, SEE GOLF CART RULES ATTACHED.
10. ATV'S, DIRT BIKES, OR OTHER VEHICLES ARE NOT PERMITTED.
11. CAMPER WASHING IS PERMITTED. VEHICLE WASHING IS NOT PERMITTED.
12. ALL TRASH MUST BE TIED AND **PLACED INSIDE** THE DUMPSTER PROVIDED AT THE VISITORS PARKING LOT. **REMEMBER NO FURNITURE, METAL, APPLIANCES, OR PROPANE TANKS ARE TO BE PLACED IN OR AROUND THE DUMPSTER.** THEY ARE TO BE DISPOSED OF BY THE OWNER OFFSITE.
13. ALL FIRES MUST BE KEPT INSIDE A FIRE RING. OPEN BURNING IS PROHIBITED!
14. FIRES MUST BE MANAGED. WE CANNOT HAVE SMOKE GOING INTO OTHER CAMPER'S UNITS. HEALTH DEPARTMENT ALSO STATES A FIRE EXTINGUISHER NEEDS TO BE CLOSE TO PUT FIRE OUT IF NEEDED.
15. WOOD PILES MUST BE NEATLY STACKED. NO MORE THAN **4 FT. TALL 8 FT. LONG AND 4 FT. DEEP,** MUST BE 10 INCHES OFF THE GROUND AND NO BRUSH PILES BESIDE IT.
16. PETS ARE PERMITTED: **MUST BE REGISTERED** MUST BE KEPT ON A LEASH OR IN A CAGE. KENNELS ARE NOT PERMITTED. OWNERS MUST CLEAN UP AFTER THEIR PET.
17. SHOT RECORDS MUST BE FILED IN OFFICE FOR YOUR PET. THIS IS A HEALTH DEPARTMENT REGULATION.
18. DO NOT WALK THRU CAMP SITES. THIS IS COMMON COURTESY. USE ROADWAYS.
19. NO CHILDREN ARE TO BE LEFT UNATTENDED AT ANY TIME.
20. **BICYCLES ARE PERMITTED ON THE PUBLIC ROADWAY DURING DAYLIGHT HOURS ONLY.**
21. ALCOHOL, LITTERING, CUTTING OF TREES, FIREWORKS, OR HORSES ARE PROHIBITED.
22. ALL BOATS MUST BE PARKED IN THE DESIGNATED AREA. UNLESS YOUR LOT HAS SPACE FOR IT.
23. **QUIET TIME IS TO BE OBSERVED BETWEEN 11:00 P.M. TO 8:00 A.M. ON SUN-THURS. 11:00PM TO 8:00AM FRI & SAT.**
24. SWIMMING IS AT THE SWIMMER'S OWN RISK. NO LIFEGUARDS ARE PROVIDED BY THE VILLAGE OF NEW LONDON. CHILDREN **18 & UNDER** MUST BE SUPERVISED BY AN ADULT (SOMEONE OVER 21).
25. AN ADMISSION CHARGE IS ASSESSED FOR ALL GUESTS OF \$3.00 EACH; 3 & UNDER IS FREE.
26. STAPLES ARE NOT TO BE USED IN PICNIC TABLES OR CABINS.
27. SEE ADDITIONAL PAGE FOR REFUND POLCY.
28. DISCOUNTS ARE GRANTED BASED ON MILITARY SERVICE, AND SENIOR CITIZENS, 60 AND OVER.
29. CAMPING IS A GREAT WAY TO SPEND TIME WITH FRIENDS AND RELATIVES. WE CONSIDER IT A PRIVILEGE TO SERVE YOU. THANKS FOR ALL YOUR HELP AND SUPPORT.

**EACH SEASONAL LOT WILL BE ALLOWED 3 VIOLATIONS AND CORRECTIONS OF THESE RULES AND REGULATIONS AFTER WHICH TIME THEY WILL HAVE VIOLATED THE TERMS OF THE PERMIT AND WILL HAVE TO LEAVE THE CAMPGROUND IMMEDIATELY AND REMOVE ALL PERSONAL BELONGINGS.**

VIOLATION OF THE PARK RULES MAY BE GROUNDS FOR TERMINATING A CAMP SITE PERMIT AND EVICTION, WITHOUT REFUND.

**VIOLATION OF THESE RULES MAY BE PUNISHABLE BY FINE OR TERMINATION OF PERMIT.**
